The restaurant taking shape 600' above Calgary's Downtown Core will be suitably named **Sky 360.**

Open daily for lunch and dinner, **Sky 360** will cater to business lunch guests, traveling tourists, and discerning diners. The menu will be described as "regional Canadian cuisine" prepared with a contemporary feel.

In addition, the restaurant will be capable of hosting private functions, special events, group dinners & receptions.

"Unforgettable food and an inviting contemporary design, combined with a magnificent revolving view of Calgary & The Rocky Mountains will make this new restaurant concept a step (or 762 steps to be exact) above the rest." said Jim Choy.

The Concorde Entertainment Groups establishments include Flames Central, The Whiskey, Mercury Lounge, Bungalow, and others.

Officially opened June 30th 1968, the Calgary Tower is the City of Calgary's most famous and identifiable physical landmark. One of the first Towers of its kind, the Calgary Tower was constructed through a continual pour of concrete using a relatively new slip-forming construction technique. Pouring began May 15, 1967 and was completed 24 days later.

Construction of this restaurant project has begun and the grand opening date is slated for June of this year.

Phase Two of this project will see an extensive renovation of the observation deck and lounge level with an exciting addition of entertainment amenities.
